



CIBC Student GIC Program¹

- Deposit a minimum \$10,000 CAD (up to \$20,000 CAD) to enroll in the CIBC Student GIC Program¹
- Efficiently transfer funds online using your preferred currency³ with no service fee⁴
- Have between \$2,000 CAD to \$12,000 CAD deposited into your new CIBC Smart[™] Account for Students when you arrive in Canada
- Receive a portion of your investment back each month for 12 months approximately \$1,000 CAD in 8 equal payments
- After 12 months, you'll have received your \$10,000 CAD investment back, plus earned interest

CIBC Student Deposit Program²

- Transfer a minimum \$1,000 CAD up to \$20,000 CAD into your new deposit account² before you move to Canada
- Efficiently transfer funds online using your preferred currency³ with no service fee⁴

Regardless of the program you choose, make sure to have the following documents ready to complete your application:

- Your passport
- Your Letter of Admission (in pdf or jpg format)
- The name of your school's campus in Canada

Once submitted, CIBC will contact you within 1 business day to confirm your application.



Section B: Student information

1	Title	Select your title from the dropdown.
2	Legal name	Enter your legal first, middle, and last name as it appears on your passport. This is important as this will be the name associated with your CIBC bank account. Please note – special characters are not allowed in these fields.
3	Name	Enter your first name and last name in your home country language (this is an optional field allowing you to include an alternate name you use in your home country).
4	School name and campus	Select the school that you have been accepted to in Canada. Please select the name of your school's campus as well, as this will help us identify the CIBC Banking Centre closest to you.
5	Tentative arrival date	This is the date that you expect to arrive in Canada. This date should be within 365 days (12 months) of the date you submit your application. If you are arriving later than 365 days, please wait and apply when you are within 365 days of arriving in Canada.
6	Tentative graduation date	This is the date that you expect to graduate from the program you are enrolled in.
7	Intended use of account	As a bank, we are required by law to ask clients about the intended use of the bank account they are applying for. This information will not be used for any other purpose. Please select a suitable option that explains the intended use of your account.
8	Occupation category / occupation description / detailed description	These questions ask you to identify what you currently do in your home country. Please select "Student". As a bank, we are required by law to ask clients for this information when they apply for a new account. This information will not be used for any other purpose.
9	Is this account to benefit a third party?	This question is asking you to confirm that your CIBC account will only be used by you and not someone else. • Select "No" if the account will only be used by you • Select "Yes" if the account will be used for someone else We're required by law to ask clients for this information when they apply for a new account. This information will not be used for any other purpose.
10	Admission letter	Please upload the acceptance / letter of admission you received from the Canadian school you will be attending. It is very important to have your legal name on this document. This can be uploaded in pdf or jpg format at a maximum size of 5 MB.



Contact details

1	Address	Enter the details of where you live including street number, street name, state / province, city, and zip / postal code. If current zip / postal code of residence are not applicable to you, please enter N/A.
2	Phone number	Enter your current phone number. Please include the area code.
3	Registered email address	Enter your email address. This is the email that CIBC will use to contact you. This will also be the email address you use to sign in to the ISBO online platform to check the status of your application. We refer to this as your "registered email address".
4	Confirm email address	Enter the same email address again. Carefully review to ensure there are no errors, and to confirm the email address used for #3 (above) and #4 (here) match. We check as well, so you'll see an error message if they are not the same.
5	Password	Create a password. This will be the password you will use to sign in to the ISBO online platform. For security purposes, we ask that it must contain at least 8 characters, at least 1 uppercase letter and 1 special character.
6	Confirm password	Enter your password again (i.e. the same password used in #3 and #4 above). Carefully review to ensure there are no errors, and confirm the password used for #5 (above) and #6 (here) match.

Passport details

1	Passport number	Enter your passport number.
2	Passport issue date	Select the date of issue on your passport. This date must be prior to today's date.
3	Passport expiry date	Select the date your passport will expire. This date must be greater than today's date.
4	Country of issue	Enter the country where your passport is issued from.
5	Date of birth	Select your date of birth. You must be 15 years or older to submit an application.

Referral details

1	Referral type	This question asks you how you heard about our ISBO. • If you have been referred by a friend, you both qualify to receive a \$25 bonus. ⁸ Visit <u>cibc.com/isbo</u> for more details

2 Referral details This question asks for details about the friend who referred you to the ISBO.

Section C: Payment summary

- 1 Review all of the details in the **student information** section on the ISBO online platform to ensure everything is correct. If you need to correct details, please scroll down and select the "Edit" button.
- 2 Carefully review the terms and conditions, deposit account, privacy details, and other section on the ISBO online platform (you may wish to print copies of each for your records). These are the official Terms and Conditions of your program.
- Once you have finished reading these documents in detail and when ready, please select the check box "I agree" to the above terms, documents and privacy consent.
- 4 When ready, click SUBMIT to complete your application.

Important notes

- Once you submit your application, CIBC will begin the process of opening your new account. You can track your
 application online by signing on to the secure ISBO platform with your registered email address and the password you
 created.
- CIBC will contact you within 1 business day via email to confirm your payment instructions. The instructions will include your newly established CIBC bank account number (i.e. where your international wire payments will be deposited).
- The international wire transfer must come from your bank account in your home country. Only one international wire transfer is permitted until you arrive in Canada and activate your account. If required, refunds can be requested on the ISBO online platform once you have submitted your wire transfer. We will ask why you need a refund, and will need to notify the Canadian Consulate of your request. The refund processing fee is \$20.00 per transaction.

- 1 Students can send minimum \$10,000 CAD up to \$20,000 CAD in any currency offered by CIBC to enroll in the GIC program. You will be required to open a CIBC Deposit account to purchase GICs.
- ² Students can send minimum \$1,000 CAD up to \$20,000 CAD in any currency offered by CIBC to enroll in the CIBC Student Deposit Program. Your expected arrival date should be within 365 days (12 months) of the date you submit your ISBO application. If you are arriving later than 365 days, you will need to wait and apply when you are within 365 days of arriving in Canada. You must be 15 years or older to submit an ISBO application.
- ³ CIBC provides access to all developed market currencies and select growth market currencies.
- ⁴ CIBC foreign exchange rates apply.
- ⁵ Eligible cards only. Standard credit criteria applies.
